**COLLECTION OF DUTY/TAXES ON 27<sup>TH</sup> JUNE, 2015 BY  
AUTHORIZED BRANCHES OF SBP AND NBP**

In continuation to our earlier letter dated 23<sup>rd</sup> June, 2015 (copy enclosed) on the captioned subject, following further instructions are issued for meticulous compliance:

- The authorized NBP branches (A, B & C) shall remain open on 27<sup>th</sup> June 2015 (Saturday) for collection of FBR taxes/duties during normal banking hours i.e. from 8:00 a.m. to 1:45 p.m.
- The NBP branches (A, B & C) will accept both cash and cheques /other instruments for collection of the taxes.
- The NBP branches (A, B & C) will settle their collections of 27<sup>th</sup> June 2015 with respective SBP BSC Offices or SBP (BSC) HOK (as the case may be) on 29<sup>th</sup> June 2015.
