NOTIFICATION
(CUSTOMS)

S.R.O. 484(I)/2016.- In exercise of the powers conferred by sub-section (5) of section 18 of the Customs Act, 1969 (IV of 1969), the Federal Government is pleased to direct that the following further amendments shall be made in its Notification No. S.R.O 693(I)/2006, dated the 1st July, 2006, namely:-

In the aforesaid Notification, in the preamble,-

- (a) in clause (a), for the figure “16%”, the figure “11%” shall be substituted;
and
- (b) in clause (b), for the Table, the following shall be substituted, namely:-

(c) after the second proviso, the following new proviso shall be added, namely:-

“Provided further that in line with Auto Development Policy (ADP) 2016-21 the 18th March, 2016 notified by Ministry of Industries and Production vide Notification No. [2\(9\)/2013-LED-II dated 2nd June, 2016](#), the additional customs-duty leviable under this notification shall not be charged on sub-components and components, imported in any kit form, by an assembler or manufacturer declared to be an investor under Category-A “Greenfield Investment” for a period of five years and under Category-B “Brownfield Investment” for a period of three years, for assembly or manufacturing of the vehicles, excluding vehicles at Sr. No. 1, 7, 9, 11 and 12, specified in the above Table”.

2. This notification shall take effect on and from the first day of July, 2016.
