 - (d) imports under sub chapters 3 and 7 of chapter XII and chapter XV of Customs Rules, 2001;
 - (e) imports under Small and Medium Enterprises and Export Oriented Units Rules, 2008;
 - (f) imports under Temporary Importation Scheme vide S.R.O. 492(I)/2009, dated the 13th June, 2009:
 - (g) Imports of HRC by manufacturers of CRC under Sr. No.5 of Notification No. S.R.O..565(I)/2006 dated the 5^{th} June, 2006;
