NOTIFICATION
(CUSTOMS)

S.R.O. 568 (I)/2017.- In exercise of the powers conferred by section 19 of the Customs Act, 1969 (IV of 1969), the Board, with approval of the Federal Minister-in-charge, is pleased to direct that following further amendments shall be made in its Notification No. S.R.O. 894(I)/2006, dated the 31st August, 2006, namely:-

In the aforesaid Notification, -

(a) in the preamble,

(i) for the words "First Schedule", the word "Schedules" shall be substituted and shall be deemed always to have been so substituted; and

(ii) after the words "of that table", the words "from the rates as specified in the First Schedule to the said Act" shall be inserted and shall be deemed always to have been so inserted; and

(b) for the existing Table, the following Table shall be substituted, namely:-
