**NOTIFICATION**  
**(CUSTOMS)**

S.R.O. 574(I)/2017.- In exercise of the powers conferred by section 19 of the Customs Act, 1969 (IV of 1969), the Board, with approval of the Federal Minister-in-charge, is pleased to direct that following amendments shall be made in its Notification No. S.R.O 741(I)/2013, dated the 28th August, 2013, namely:-
