1. The **Government** of Islamic Republic of Pakistan has **received a credit** from the International Development Association for the **Tax Administration Reform Project** and intends to apply part of the proceeds of this credit to cover eligible payments under the contract for **Construction of Transit Accommodation for Regional Tax Office, Abbottabad**. Bidding is open to all bidders from eligible source countries as defined in the guidelines for Procurement under IBRD Loans and IDA Credits.
2. The **Federal Board of Revenue**, located on Constitution Avenue, Islamabad invites sealed bids from eligible bidders for the **Construction of Transit Accommodation for Regional Tax Office, Abbotabad**.
3. A complete set of bidding documents in *English* may be purchased by interested bidders by submitting a written application at the given below address after payment of nonrefundable fee *equivalent to Pak Rs. 1000/-*. The method of payment will be direct deposit under Federal Government of Pakistan **Head of Account C-03870-Non Tax receipts - others** in the National or State Bank of Pakistan. Interested Bidders who wish to receive the Bidding Documents through courier should deposit an additional amount of Rs. 300/- for delivery within Pakistan or alternatively can send the pre-paid shipping envelop. 4. Bids shall be valid for a period of **120 days** after Bid opening and must be accompanied by bid security in the shape of **Demand Draft/Bank Guarantee, CDR / Pay Order** on the name of **Project Director - TARP, FBR, Islamabad** and shall be delivered on or before **1100 hours** on **23rd August, 2011** (Tuesday) in the office of **Secretary (Proc. II) TARP, Room No. 448, FBR House, Islamabad**, which will be opened at **1130 hours** on the same date and at the same location in the presence of the bidders, who wish to attend.
5. In case of Bank Guarantee, Demand Draft, CDR and Pay Order, the validity period of these instruments will be **28 days** beyond the Bid validity period or as extended.

6. All bidders shall be required to submit with their bids, qualification information specified in the bidding documents. This information shall be used to evaluate the bidder on post-qualification criteria, whether the bidder is qualified to perform the work or not.
7. Bids are required to be submitted on **Item Rate Basis** (not on the basis of Composite Schedule of Rates with percentage premium) and the rates and amounts (in Rupees) must be filled by the bidder for each item in the Bill of Quantities and provide a total price. Non-compliance may result in rejection of bid.
8. Bidders should give their **best and final price** in their bids as no negotiations are expected.
9. All Government Taxes shall be deducted as per law. Proof of registration with Income Tax and Sales Tax Department should be enclosed with the Bid.
10. As provided in the bidding documents, bidders engaged in corrupt or fraudulent practices (including collusion/pooling) will be declared ineligible, either indefinitely or for a stated period of time for award of a contract financed by "**The World Bank**".
11. For facilitation of bidders, a **Pre-Bid Conference** will be held on **11th August, 2011 (Thursday)** at **11 A.M** in the Conference Room of FBR House, Constitution Avenue, Islamabad,
12. The successful bidder is required to sign an integrity pact with FBR as per Government's instructions as per sample Form provided in the Bidding Documents.
