5. All the bids received within the prescribed time limit will be opened by authorized officers of the RTO in the presence of bidder's representatives who chose to attend at 4:30 p.m. on the closing date, in the Committee Room of Regional Tax Office, Queen's Road, Sukkur.
6. Any type of correcting fluid or over-writing will not be acceptable on the Tender Form.
7. All Governments taxes will be deducted as per laws / rules.
8. The bidder should enclose a copy of each of NTN Certificates, Sales Tax Registration No. & CNIC.
