2. The tender document(s) can be obtained from Administration Branch, MCC PaCCS, Custom House, Karachi, on cash payment of **Rs.1,000/- (non-refundable)** during office hours on or before **25.02.2012**.

Terms and Conditions:


- i. The tender shall be granted on the basis of competitive bidding process, specified in Public Procurement Rules, 2004.
- ii. The bidders should be registered with Income Tax and Sales Tax Departments, having their own office & phone / fax numbers (if found contrary the tender will be rejected).
- iii. The bidders should not be black-listed by any authority in the past.
- iv. Bidders are required to furnish Security Deposit of **Rs.50,000/- or 5%** of their offer, whichever is higher, in the shape of pay order or demand draft from a scheduled bank in favour of the **Collector, Model Customs Collectorate of PaCCS, Custom House, Karachi**. This Security Deposit shall be refunded to the unsuccessful tender participants. The Security Deposit shall be returned to the successful bidder on completion of the tender contract.
- v. Sealed tender bids on prescribed tender document must be delivered to the address given below on **25th February, 2012**, before **2:00pm** and shall be opened at **3:00pm** on the same day in the presence of the participants of the tender or their authorized representatives who desire to attend.
- vi. The Collector, Model Customs Collectorate of PaCCS, Karachi may reject or accept any offer or ask for any amendment in the specifications / offer or reduce or enhance the quantity of items meant for purchase, without assigning any reason.

- vii. Bidders shall quote their final prices both in figures and in words on free delivery basis, any cutting / overwriting and correction in the tender form will not be accepted.
- viii. Bidders are required to give complete sample at the time of bidding.
- ix. The tender bid must be valid for at least **90 days**, after opening of tenders.
- x. The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.
- xi. Procuring agencies shall announce the results of bid evaluation in the form of a report giving justification for acceptance or rejection of bids at least ten days prior to the award of procurement contract. A copy of the result shall be placed on the notice board of Model Customs Collectorate of PaCCS, Custom House, Karachi.
