Terms and Conditions:

1. The terms & Conditions and other specifications of each items will be available on the "Tender Notice" which may be obtained from the office of the Collector Model Customs Collectorate SITE area Hyderabad during office hours. These terms and conditions are according to Form CPWD 6 & 7 and PEC guide lines.
2. The bidder shall furnish earnest money in the shape of a Pay Order equivalent to 3% of the estimated value of their bids in favor of the Collector Model Customs Collectorate Hyderabad.
3. The tender Document will be available from the date of publication of this tender on PPRA website during office hours on payment of Rs.1000 per tender (Non-Refundable) at the MCC Hyderabad and the Assistant Collector Customs Shikarpur road Sukkur. The tender document obtained from the Assistant Collector Sukkur's office will be submitted to MCC Hyderabad for further process by the bidder themselves before the due date.
4. The bids should reach this office with in fifteen (15) days of the publication of this notice on PPRA website after which no bid will be entertained.
5. All the bids received with in the prescribed time limit will be opened by the authorized officer of MCC in the presence of bidder's representatives who chose to attend at 1:30 PM on the closing date, in the Committee room of MCC , SITE area Hyderabad.
6. Any type of correcting fluid or over writing will not be acceptable on the tender Form.
7. All the Govt taxes will be deducted as per rules/law.
8. The bidder should enclose a copy of each of NTN Certificates, Sales Tax Registration No and CNIC.
9. Incomplete tender will not be accepted in any case.
10. Site can be visited during working hours at MCC SITE area Hyderabad and Assistant Collector Shikarpur road Sukkur.
11. Paymentw will be made on satisfactory completion of work verified by the committee.
12. The Bids Evalutaion Committee has right to verify quality and quantity of the work.
13. The Contractor will complete the work at the specified location within mentioned days in agreement after the signing of contract.
14. The bids and Evaluation Committee reserve the right to alter the quantities of items and specifications, if required and provision of any additional itme not mentioned in the tendered items from the successful vender will be done after the mutual agreement.
