

Terms and Conditions:

- 1) Tender Document may be obtained upon payment of *Rs.1000/* (one thousand) non-refundable during working hours (0900 hrs. to 1700 hrs.) from the office of the cashier/Head Clerk.
- 2) Quotations should include all applicable taxes including, income tax, sales tax, stamp duty etc. Rates quoted without taxes shall not be considered and such bids shall be liable to be rejected.
- 3) Rates should be quoted in Pakistan Rupees and quotations should be valid for a period of 90 days.
- 4) Quotations shall be **compared item-wise** and order placed accordingly.
- 5) Over-writing in the offered prices shall be acceptable. Such bids shall be liable to be rejected.

- 6) Bidders are required to submit "Earnest Money" (equal to 2% of total quoted value), in the form of pay-order/draft, in favor of "Directorate General of Training and Research (Customs) Karachi.
- 7) Earnest money of the unsuccessful bidders will be returned/refund at the earliest.
- 8) Bidders are required to provide: (a) Earnest Money (b) copy of Sales-Tax Registration Certificate (c) copy of NTN Certificate. (d) Brief profile of the company. (e) Explain if defaulted/black-listed at any stage, including the current status. (f) Verifiable list of clients along with contact person's name and telephone number, Email address to whom these services are being provided by the company.
- 9) Non-compliance with the delivery and installation schedule of the project will render the bidding company liable to penalty of 50% for delay of 2 weeks and 10 of the total charges for delay of 4 weeks. Any further delay would lead to cancellation/discontinuation of the contract.
- 10) Bidders should be providing similar solution and services for at least 3 years.
- 11) Bidder must provide name, address, telephone and fax numbers of third parties involved in the tender, together with a description of role or element of the contract to be full filled by any third party.
- 12) Submission of false statement/documents and concealment of any information by the bidders will lead to their disqualification /blacklisting.
- 13) Selection Criteria: (a) Quality (b) Delivery time. (d) Cost.
- 14) Payment will be made on the basis of inspection /testing by the Technical Team and Subsequent report submission.
- 15) DGTR Karachi reserves the right to (accept or reject bides) or the bidding process due to change in requirements as provided under the rules.

Sealed quotations along with Earnest Money (2% of the quoted value) should reach undersigned latest by 28th March 2013 by the 1100 hours. Bids shall be opened on the same day by 1230 hours in the presence of the bidders or their authorized representatives.
