4. The 25% of total Bid money in shape of Bank Draft or Pay order will be deposited in favour of department after completion/acceptance of successful bid.
5. The payable amount of bid will be deposited within Ten days period. In case of non depositor failure to deposit receiving amount would be forfeited in favour of department.
6. Successful bidder will be bound to change blue of colour of Vehicles/Vehicle.
