It is to inform that following quantity of seized/confiscated diesel oil is presently available at Model Customs Collectorate (Preventive), Karachi.



- i. Mode of payment shall be in form of a Pay Order drawn in favour of Collector of Customs MCC (Preventive), Karachi.
- ii. The delivery of Diesel/Petrol shall be taken at CPF Bond/NMB Wharf as the case may be.
- iii. 10% withholding tax shall be charged on the value of the oil.
- iv. The auction will be purely on "As is where is" basis.
- v. Quantity of goods may vary due to unavoidable circumstances.

If you are interested in purchasing the above mentioned quantity of Diesel oil on the conditions specified above, you may send sealed tender, quoting therein per liter price of diesel oil, inclusive of all taxes but exclusive of 10% withholding tax as described above, with 25% of the Custom price in the shape of pay order in favour of Collector of Customs, MCC (Preventive), Custom House, Karachi on or before 20/12/2014 by 12:00 noon and the tender will be opened at 03:00 p.m. on the same day.
