2. Bidders may bid for any one or more of the above lots. Evaluation of bids and award of contract will be lot-wise

Interested eligible bidders may obtain further information from the Model Customs Collectorate of Appraisement (West), Karachi and inspect the site for survey purpose at the address given below from 0900 to 1500 hours on any working day. Prior intimation is required to be sent for arranging the site survey.
4. A complete set of bidding document in English may be purchased by interested bidders on submission of a written application on Company's Letter Head to the address below and upon payment of non-refundable fee equivalent to Pak Rs. 300/-. The method of payment will be through Pay Order in the name of "Collector, MCC Appraisement (West), Karachi. Interested bidders who wish to receive the Bidding Documents through courier should provide an additional amount of Rs. 300/- for delivery within Pakistan. A pre bid meeting, with the potential bidders will be held at 1130 hours on 14.03.2014. Venue of the meeting will be conference room at 5th Floor of the Custom House, Karachi
5. Bids must be delivered at the address below on or before 1100 hours on 18.03.2014. All bids must be accompanied by an earnest money amounting to 2% of the bid amount in the shape of Pay order which shall remain valid for a period of 120 days after Bids opening. Late bids will be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at 1130 hours, on 18.03.2014.
6. Price quoted shall be paid Delivered Duty Paid (DDP) including all applicable taxes / duties.
7. Bids shall be valid for period of 03 months after opening.
8. All Government Taxes shall be deducted as per law. Proof of registration with Income Tax Department and Sales Tax Department should be enclosed with the Bid.

9. Bidders are requested to give their best and final prices as no negotiations will be held.
10. Bidders engaged in corrupt or fraudulent practices (including collusion / pooling) will be declared ineligible either indefinitely or for stated period of time.
