- Bidders are required to state brand, model manufacturer's name, specifications and country of origin clearly in their offer and provide the original technical literature otherwise the offer shall be ignored.
- The price offered will include all duties and taxes and the expenses incurred on supplies including installation. Competitive after sales services (with/without parts) will be given priority

3. Supplier shall furnish warranties/guaranties for three year or more for satisfactory performance of the equipment. The warranty/guarantee will be effective from the date of installation.
 4. Bidders are required to confirm installation of the equipment and making it fully operational including briefing to the staff regarding proper handling and after sales service at least for three years.
 5. The successful bidder shall provide the equipments within fifteen days from the date of acceptance of tender.
 6. In case the bidder fails to supply the goods as per laid down terms and conditions the earnest money shall be forfeited.
 7. Tenders are required to quote price for one year subscription for Antivirus.
 8. The price offer will include all duty & taxes and expenses incurred on supplies.
 9. The price will be quoted in local currency i.e. Pak Rupees.
 10. The tenders are required to furnish 2% of the total amount as earnest money in the shape of Pay Order or Demand Draft from a scheduled bank in favour of the **Directorate General of Transit Trade, Custom House, Karachi.**
 11. The tenders are required to provide sales tax registration & NTN certificate.
 12. In case the supplier fails to supply the goods as per laid down conditions, necessary action will be taken against the supplier as deem appropriate including forfeiture of **earnest money.**
 13. The department reserves right to cancel the bid or part thereof without giving any reason(s).
 14. Government duties and taxes including stamp duty @ 0.25% of total contract amount should separately be mentioned in the Financial Proposal.
