4. The bids should reach this office within fifteen (15) days of the publication of this notice on PPRA Website after which no bids will be entertained.
5. All the bids received within the prescribed time limit will be opened by authorized officers of the RTO in the presence of bidder’s representatives who chose to attend at 4:30 p.m. on the closing date, in the Committee Room of Regional Tax Office, Queen’s Road, Sukkur.
6. Any type of correcting fluid or over-writing will not be acceptable on the Tender Form.
7. All Governments taxes will be deducted as per laws / rules.
8. The bidder should enclose a copy of each of NTN Certificates, Sales Tax Registration No. & CNIC.
9. Incomplete tender will not be accepted in any case.
10. The Chairman, Purchase Committee, RTO, Sukkur reserves the right to cancel any or all bids either in whole or in part as per PPRA rules.
11. The payment will be made on the supply of items and clearance of bills from District Accounts Officer, Sukkur.
