2. The tender documents can be obtained from the administration branch MCC (Appraisalment-East), Custom House, Karachi on cash payment of **Rs. 1000/- (non-refundable)** during office hours on or before **18.09.2014**.


TERMS & CONDITIONS

1. The offer must contain financial impact, technical solution and after sale services to be offered by the bidder.
2. The price offered will includes all duties and taxes and the expenses incurred on supplies including transportation, shipping, installation, etc., where required.
3. Bidder are required to furnish a Security deposit of **5%** of their offer in the shape of pay order or demand draft from a scheduled bank in favor of **Collector, Model Customs Collectorate (Appraisalment East) , Custom House, Karachi**, as guarantee for satisfactory performance of the tender obligation. If a bidder fails in the performance of his/ her tender obligations, the security deposit shall be forfeited, without any liability on the part of Collector, Model Customs Collectorate of Appraisalment (East), Custom House, Karachi. The security deposit will be returned to the unsuccessful bidders.

4. The bidders are required to provide proof of Sales Tax Registration and NTN from the concerned departments.
5. The successful bidder shall provide the supply of above mentioned goods within six working days of acceptance of tender and issuance of purchase / work order in this regard.
6. In case the bidder fails to supply the goods as per laid down terms and conditions the earnest money shall be forfeited without any further notice and the purchase / work order shall stand cancelled. The Collector, Model Customs Collectorate of Appraisalment (East), Customs House, Karachi shall be free to award this Tender to some other party.
7. The Successful bidder is bound to provide satisfactory after sale services, during the warrantee period of supplied equipment.
8. The Collector, MCC Appraisalment (East), Custom House, Karachi:-
 - a. *may reject or accept any offer,*
OR;
 - b. *may ask for any amendment in the specifications / offer,*
OR;
 - c. *may reduce or enhance the quantity of items meant for purchase, or purchases may be made piecemeal as per rule 33 of PPRA 2004.*
9. Bidders shall quote their final prices both in figures and in words, any cutting / overwriting and correction in the tender form will not be accepted.
10. The competent authority also reserve the right to cancel the tender awarded at any time on the notice of fifteen days period and the party to whom the tender is awarded has no right to file appeal at any forum/appellate authority.
11. The tender bid must be valid for at least **90 days**, after opening of tenders. Government duties and taxes including stamp duty @ 0.25% of total contract amount should separately be mentioned in the Financial Proposal.
12. The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the

grounds for its rejection of all bids or proposals, but is not required to justify those grounds.

13. The offer shall be valid for and up to 17.12.2014.
