**TENDER NOTICE NO. 12/2015-16**

Scaled Tenders for the year 2015-2016 is invited from original firms /authorized suppliers for supply of the Magazines, Periodicals, Websites and Software items (online & print) for one year subscription on daily basis (24 hours availability) to The Directorate General Customs Valuation, Custom House Karachi.

2. Detail specifications of the Magazines, Periodicals, Websites, Software items and the terms and conditions and Evaluation criteria for participating in Tender can be obtained from the undersigned on any working day or may be downloaded from the website of PPRA ([www.ppra.org.pk](http://www.ppra.org.pk)).
3. Bidders are required to furnish security deposit of 5% of their offer in the shape of pay order or demand draft from scheduled Bank in favor of **Director, Directorate General Customs Valuation, Karachi, Custom House, Karachi**. This security deposit shall be refunded to the unsuccessful participant of the tender. The security deposit of the successful bidder will be retained until the purchase order completed. The bidders should not be black-listed by any authority in the past.
4. Sealed tender bids on prescribed tender document must be delivered to the address given below latest by **28.12.2015**, before **03:00pm**. The same shall be opened at **4:00pm** on the same day in the presence of bidders of the tender or their authorized representatives who desire to attend.
5. The tender bid must be valid for at least **90 days**, after opening of tenders. Government duties and taxes including stamp duty @ 0.25% of total contract amount should separately be mentioned in the Technical Proposal.

**Terms and Conditions**

- i. The purchasing contract shall be granted on the basis of competitive bidding process, specified in Public Procurement Rules, 2004.
- ii. The bidders should be registered with Income Tax and Sales Tax Departments, having their own office & phone / fax numbers (if found contrary the bid will be rejected).
- iii. The bidders should not be black-listed by any authority in the past.
- iv. Bidders are required to furnish Security Deposit 5% of their offer, in the shape of pay order or demand draft from a scheduled bank in favor of the **Director, Directorate General Customs Valuation, Karachi, Custom House, Karachi**. This Security Deposit shall be refunded to the unsuccessful tender participants. The Security Deposit shall be returned to the successful bidder on completion of the tender contract.

- v. The price shall be offered in local currency and include all duties and taxes and the expenses incurred on supplies including transportation, installation, labor etc, where required.
- vi. Bidders shall guarantee for one year un-interrupted supply of the Magazine/ Journal / Web Site and must be as per the enclosed specifications.
- vii. Sealed tender bids on prescribed tender document must be delivered to the address given below on **28.12.2015**, before **03:00pm** and the same shall be opened at **04:00pm** on the same day in the presence of the participants of the tender or their authorized representatives who desire to attend.
- viii. The Director, Directorate General Customs Valuation, Karachi, Custom House, Karachi:-
- a. *may reject or accept any offer,*
- OR
- b. *may ask for any amendment in the specifications / offer,*
- OR
- c. *may reduce or enhance the quantity of items meant for purchase, or purchases may be made in piecemeal as per rule 33 of PPRA 2004.*
- ix. Bidders shall quote their final prices both in figures and in words, any cutting / overwriting and correction in the tender form will not be accepted.
- x. The purchase will be made strictly in accordance with PPRA Rules,2004.
- xi. The admissible taxes shall be deducted at source.
- xii. The tender bid must be valid for at least **90 days**, after opening of tenders.
- xiii. The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.
- xiv. Procuring agencies shall announce the results of bid evaluation in the form of a report giving justification for acceptance or rejection of bids at least ten days prior to the award of procurement contract. A copy of the result shall be placed on the notice board of **Directorate General Customs Valuation, Karachi**, Custom House, Karachi.
- xv. Each bid shall comprise one single envelope containing, separately, financial proposal and technical proposal (if any). All bids are received shall be opened and evaluated in the manner prescribed in the bidding document.
