Other terms and conditions:

- (i). The bids are to be submitted to the undersigned in sealed / confidential cover at the address mentioned above latest by 09th February, 2015 at 1100 hours and the same will be opened at 1130 hours on the same day by a Purchase Committee in the presence of bidders or their authorized representatives who wished to be present.
- (ii). The quoted rates must be inclusive of all applicable duties / taxes.

- (iii). Earnest money / bid security deposit @ five percent of the bid price (refundable) in shape of call deposit in favour of Director, Intelligence & Investigation (Customs)-FBR, Peshawar should be enclosed with the bid. Any bid which is not accompanied by this earnest money / bid security at the time of opening of bid shall be outright rejected.
- (iv). The quantity of items to be purchased can be increased or decreased at the time of supply orders.
- (v). The validity period of the bid / rates will be applicable upto 30.6.2015 from the date of opening thereof.
- (vi). All items will have to be supplied strictly as per specifications given above and within 15 days of the issuance of purchase order.
- (vii). Attested copies of Sales Tax Registration and NTN must be attached with the bid.
- (viii). Sample of the materials / items/catalogue must be accompanied with bids and to be produce at the time of opening of sealed bids otherwise the bids will be rejected.
- (ix). Procuring agency may reject all bids or proposals at any time prior to the acceptance of bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.
- (x). Payment will be made to the successful bidder in the shape of crossed Cheque after complete supply of all the bid items.
- (xi). No bid shall be entertained after given cut of date and time.
