

- 2) In case of any substandard items, the contract shall be terminated forthwith, forfeiting security money in favour of the Government.
- 3) Tenders should be accompanied with items-wise rate list of each item, including all taxes.
- 4) The contractors/firms must be registered for Sales Tax and Income Tax, duly supported by copies of STRN and NTN Certificates.
- 5) The contractor/firms should have vast experience of supply electrical/civil items to the Government Departments, duly supported by copies of required experience certificates.
- 6) Bank Draft @ 5% of the quoted price of all items, as security money in favour of DDO, FBR(HQ) Islamabad, will have to be attached with the tender.
- 7) Initially the contract will be for one year, extendable/renewable afterwards upto three years subject to satisfactory supply.
