




The Directorate General, Intelligence and Investigation-FBR, Islamabad invites sealed bids on percentage basis from well reputed Contractors based at Islamabad-Rawalpindi duly enlisted/ registered with CDA/ Pak PWD and having valid Sales Tax Registration, NTN & Vender number for following repairs and maintenance work of office building of this Directorate General:-

Terms and conditions:

- a) Tender form showing details/ specifications of the requisite repairs and maintenance work can be obtained from General Branch of this Directorate General on any working hours on cash payment of tender cost (non-refundable). No tender form will be issued on the date of opening of tender.
 - b) The bids are to be submitted to the undersigned in sealed/ confidential cover at the address mentioned above and the same will be opened by a Committee on the date/ time mentioned above in the presence of bidders or their authorized representatives who wished to be present.
 - c) The quoted rates must be inclusive of all applicable duties/ taxes.
 - d) Earnest money/ bid security deposit @ rate three percent of total bid amount (refundable) in shape of call deposit in favour of the DDO, Directorate General, Intelligence and Investigation-FBR, Islamabad should be accompanied with the bid. Any bid which is not accompanied by the earnest money/ bid security at the time of opening of bid shall be outrightly rejected.

- e) All work will have to be completed strictly as per specifications mentioned in the tender document and all the work will have to be completed within 30 days of the issuance of work order.
- f) The successful bidder shall have to furnish a 'Performance Security' equal to 10% of the Contract Price in the shape of Bank Guarantee from any scheduled Bank in Pakistan for a period of three months from the date of completion of work.
- f) Attested copies of the Registration Certificates issued by the CDA/ Pak PWD alongwith Sales Tax Registration and NTN must be attached with the bid.
- g) The Directorate General, Intelligence and Investigation-FBR, Islamabad reserves the right to reject any or all bids without assigning any reason thereof.
- h) Payment will be made after satisfactory completion of all the repairs and maintenance work and approved by the committee constituted for the purpose.
- i) No bid shall be entertained after given cut of date and time.
