- 5- All the bids received within the prescribed time limit will be opened by authorized officers of the RTO in the presence of bidder’s representatives who chose to attend at 04:30 PM on the closing date, in the Committee Room of Regional Tax Office, Queen’s Road, Sukkur.
- 6- Any type of correcting fluid or over-writing will not be acceptable on the Tender Form.
- 7- All Governments taxes will be deducted as per laws / rules.
- 8- The bidder should enclose a copy of each of NTN Certificates, Sales Tax Registration No. & CNIC.
- 9- Incomplete tender will not be accepted in any case.
- 10- The Chairman, Purchase Committee, RTO, Sukkur reserves the right to cancel any or all bids either in whole or in part as per rules.
