**Other terms and conditions:**

- i. The bids are to be submitted to the undersigned in sealed / confidential cover at the address mentioned above latest by 11am on 29-3-2016. The same shall be opened at 11:30 am on the same day by a Purchase Committee in the presence of bidders or their authorized representatives who wish to be present.
- ii. The quoted rates must be inclusive of all applicable duties / taxes.
- iii. The bidders should submit separate BID (Tender) for each item i.e Air condition, CCTV Camera, Sound System and Hardware and accordingly BID (Tender) will be evaluated.
- iv. Earnest money / bid security deposit @ five percent of the bid price (refundable) in the shape of call deposit in favour of Director, Intelligence & Investigation (Customs)-FBR,

Peshawar should be enclosed with the bid. Any bid which is not accompanied by this earnest money / bid security at the time of opening of bid shall be outright rejected.

- v. The quantity of items to be purchased can be increased or decreased at the time of supply of orders.
- vi. The validity period of the bid / rates will be applicable upto 30.6.2016 from the date of opening thereof.
- vii. All items will have to be supplied strictly as per the minimum specifications given above and within 20 days of the issuance of the purchase order.
- viii. Attested copies of Sales Tax Registration and NTN must be attached with the bid.
- ix. Catalogue/photos of the items must accompany the bids or should be produce at the time of opening of the sealed bids.
- x. The Procuring agency may reject all bids or proposals at any time prior to the acceptance of the bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for rejection of any/all bids or proposals, but is not required to justify those grounds.
- xi. The Purchaser/Client may reject the Goods, if they fail to conform to the Technical Specifications, and the Contractor shall replace the rejected Goods, within three working days, free of cost to the Purchaser/Client.
- xii. Payment will be made to the successful bidder in the shape of crossed Cheque after complete supply of all the bid items.
