



The bidders are required to furnish Security deposit 3% of bid value in the shape of Pay Order (PO), Demand Draft (DD) or Call Deposit Receipt (CDR) in the name of the Drawing and Disbursing Officer, OFFICE OF THE PROJECT DIRECTOR JICA SCANNER PROJECT KARACHI This Security Deposit shall be refunded to the unsuccessful tender participants. The Security Deposit shall be returned to the successful bidder on completion of the tender contract.
5.	The price shall be offered in local currency and shall include all duties and taxes and the expenses incurred on supplies including transportation, installation, labor etc, where ever required
6.	The tender bid must mention the type of warrantee and after sale services, if any.
7.	Sealed tender bids on prescribed tender document must be delivered to the address given below before 5 <sup>th</sup> April, 2016 at 10.30 a.m and shall be opened at 11.00 a.m on the same day in the presence of the participants of the tender or their authorized representatives who desire to attend.
8.	Bidders shall quote their final prices both in figures and in words on free delivery basis, any cutting/ overwriting and correction in the tender form will not be accepted and will make the bid invalid.
