- 5 Interested bidders are required to submit their bids by 1100 hours on or before the 15th day of the publication of this tender in the print media. Earnest money amounting to 5% of the bid amount shall be accompanied with the bid in the form of Pay Order (Refundable) in favor of *Directorate of Reforms and Automation (Customs), Custom House, Karachi*. The tender will be opened on the last day of submission at 1400 Hours at the office of undersigned. Bids will be opened in the presence of bidder's representatives who choose to attend the same.

7. All bids shall be valid for 180 days from the date of opening of tender.
