Model Customs Collectorate invites sealed bids (single stage –one envelope) under PPRA Rules, 2004 for supply of following items for Model Customs Collectorate, Multan from experienced and authorized dealer/firms/supplies duly registered with Income Tax & Sales Tax Department. Detail is as under:

- Tender bid must be accompanied by a Bank Draft/Pay Order of the amount as mentioned above against supply of each items in favour of the Collector of Customs, Model Customs Collectorate, Customs House, Multan as earnest money, otherwise tender bid shall be rejected.
- The bidder should be on active taxpayer list (ATL) of FBR.
- The bidder (firm) should attach an affidavit on Rs. 100/- stamp paper (latest and original) to the effect that the firm has not been black listed by any Govt. Department. If this certificate is found to be bogus or false, appropriate action against the firm will be taken including forfeiting of security or may attach ATL proof.

- Bid may be submitted inclusive of all taxes along with details of warranty, delivery time period and sample of each item where necessary.
- Supply of all items shall be ensured according to supply order. The quantity of any item mentioned above can be increased/decreased/abolished/cancelled depending upon the budget grant.
- Bids must be reach the office of the undersigned on or before 03.00 P.M on 10.04.2019 which will be opened on the same day at 04.00 P.M in the presence of bidders or their authorized representatives who care to attend.
- Tender/bidding documents or detailed specification of items, terms and conditions may be obtained from the office of the undersigned upon formal request on the letter head of the bidder (firm) or supplier on payment of Rs.250/- during the office hours on or before 09.04.2019.
- The validity period of the bid/rates will be applicable up to six month from the date of opening thereof.
- The procuring agency reserves the right to reject any or all the bids under rule 33 of Federal PPRA Rules, 2004.
