1. Bids are to be submitted on Tender Forms as per PPRA Rules, 2004 which can be obtained from Administration Branch Preventive, 6<sup>th</sup> Floor, Custom House, Karachi on payment of Rs, 2000/- (Non-Refundable) per set during office hours from the date of publication of this advertisement.
2. Sealed bids must be dropped in the tender box placed in the Administration Branch MCC Preventive, 6<sup>th</sup> Floor, Custom House, Karachi by 10<sup>th</sup> June, 2019 upto 1400 hours. These bids will be opened on same day at 1500 hours in the presence of bidders or their authorized representatives who may like to witness the opening up of sealed tenders.
3. Following documents must be attached with the tender documents;
  - a. Copy of valid Sales Tax Registration

- b. Copy of valid Income Tax Registration
  - c. Business profile for the last three years
  - d. Authority Letter showing details of authorized person
  - e. Copy of CNIC of authorized person
  - f. An affidavit confirming that the company is not black listed anywhere
4. The competent Authority reserves the right to accept or reject any or all bid(s) in accordance with the provisions envisaged under Rule-33 of PPRA Rules 2004.
  5. No bidder shall be allowed to alter or modify his/her bid after opening of the bids.
  6. No conditional bids will be accepted.
  7. 2% Security Deposit of the bid value in shape of pay order/call deposit in favour of Collector of Customs Preventive, Karachi should be submitted along with the bidding document, which shall be refunded within seven (7) days to the unsuccessful bidder.
  8. Successful bidder(s) shall be required to pay all taxes as per Government Rules.
  9. Successful bidders will be required to pay all duties and taxes as per Government Rules, alongwith the stamp duty @ 0.2% and shall furnish a bank guarantee/pay order of 5% of the total bid value as performance guarantee which will be refunded after maturity of six month from the date of award of contract.
