- 4. Detailed deliberations were made during the meeting. Following are the questions/queries raised by the prospective bidders and replied by the department, as under:

S.No.	Query/Question/Clarification sought by the prospective Bidders.	Answer
1.	Bidders jointly requested for the substitution of "Performance Guarantee" with "Pay Order/Demand Draft" which will be more convenient for them.	The validity of the Pay Order/Demand Draft is six months. Performance Gurantee is of more than one year, so the FBR is unable to accept the proposal. Moreover, Performance Guarantee will be submitted by only successful bidder. For earnest money, they are already allowed to submit Pay Order/Demand Draft.
2.	Quoted price of per unit will be in round figure without GST?	Replied, yes, quoted price will be in round figure with or without GST.
3.	Period of 3 days for supply of local item(s) and 7 days for imported item(s) is not sufficient, same may be amended as 7 days for local items and 30 days for imported items.	FBR will re-consider and shall communicate the revised delivery time.
