SALES TAX GENERAL ORDER NO.13/2010

In exercise of the powers conferred by clause (d) of section 4 of the Sales Tax Act, 1990, the Federal Board of Revenue is pleased to make the following further amendments in its Sales Tax General Order No.07 of 2007 dated the 13th September, 2007, namely:-

In the aforesaid General Order, in the Table-,

- (a) against S.No.917 in column (1), in column (4), after the figure "2805667951645" the figure "2706467757234" shall be added;
- (b) Serial numbers 1069 and 1185 in column (1) and the entries relating thereto in columns (2), (3) and (4) shall be omitted;
