**ORDER  
(INCOME TAX)**

Subject: - **JURISDICTION OF COMMISSIONERS OF INCOME TAX, LARGE TAXPAYERS' UNIT, ISLAMABAD.**

In exercise of the powers conferred by sub-section (1) of section 209 of the Income Tax Ordinance, 2001 (hereinafter referred to as the said Ordinance) and in suppression of all previous orders in respect of jurisdiction, the Federal Board of Revenue is pleased to direct that the Commissioners of Income Tax specified in column (2) of TABLE-A below, shall exercise the powers and perform the functions, under the said Ordinance, specified in column (3) of Table-A below, in respect of the persons, as specified in Table-B below.

4. It shall take immediate effect.
