**ORDER
(INCOME TAX)**

Subject: - **JURISDICTION OF COMMISSIONERS OF INCOME TAX,
REGIONAL TAX OFFICE, LAHORE.**

In exercise of the powers conferred by sub-section (1) of section 209 of the Income Tax Ordinance, 2001 (hereinafter referred to as the said Ordinance), the Federal Board of Revenue is pleased to order following amendments in the jurisdiction order C. No. 10(11)IT-Jud/2005, dated 02.08.2008:-

- (i) The entry "a)" in column (4) against S. No. 4 is substituted as under: -

"All cases or classes of cases or persons or classes of persons of non-corporate sector or areas falling under the jurisdiction of Audit Division-II, excluding cases assigned to Enforcement & Collection Division-III)."

- (ii) The entry "b)" in column (4) against S. No. 4 is hereby omitted.

- (iii) In entry "a)" of column (4) against S. No. 5 is substituted as under: -

"a) All cases and classes of cases or persons or classes of persons of non-corporate sector, or area, falling within the limits of Civil Districts of Kasur, Sheikhpura, Nankana Sahib, Okara and following towns of Civil District of Lahore: -

- i) Gulberg Town
- ii) Samanabad Town
- iii) Nishter Town
- iv) Iqbal Town

- (iv) The entry “b)” in Column (4) against S. No.5 occurring for second time will be renumbered as “c)”.
- (v) The entry “c)” in column (4) against S. No. 5 is substituted as under: -
 - “d) All cases of Tax Withholding and Collection Agents ‘not liable to tax’ (excluding corporate cases assigned to the Commissioner of Income Tax (Enforcement & Collection Division-II) falling within the limits of Civil Districts of Lahore, Kasur, Shiekhupura, Nanakana Sahib and Okara.”
