**ORDER
(INCOME TAX)**

Subject: - **JURISDICTION OF COMMISSIONERS OF INCOME TAX,
REGIONAL TAX OFFICE, LAHORE.**

In exercise of the powers conferred by sub-section (1) of section 209 of the Income Tax Ordinance, 2001 (hereinafter referred to as the said Ordinance), the Federal Board of Revenue is pleased to order following amendment in the jurisdiction order C. No. 10(11)IT-Jud/2005, dated 02.08.2008:-

- (i) The entry "n)" in column (3) against S. No. 4 is hereby omitted.
- (ii) The following three entries "j)", "k)" and "l)" are hereby inserted in column (3) after entry "i)" against S. No. 3: -
 - j) Effect collection and recovery of tax under Part-IV of Chapter-X;
 - k) Issue refunds under Part-VI of Chapter-X including refund adjustments; and
 - l) Charge additional tax under Part-XII of Chapter-X.
- (iii) In entry "a)" of column (4) against S. No. 4, before full stop (.), the words and symbols "(except salary cases)" are hereby inserted.
- (iv) The entry "j)" in column (4) against S. No. 4 is hereby omitted.
- (v) The following entry "j)" is hereby inserted in column (3) after entry "i)" against S. No. 3: -
 - j) To process/finalize complaints in respect of new cases.

(vi) The following entry “p)” is hereby inserted in column (3) after entry “o)” against S. No. 4: -

p) To process/finalize complaints in respect of new cases.

(vii) The following entry “m)” is hereby inserted in column (3) after entry “n)” against S. No. 3: -

m) To process/finalize complaints in respect of new cases.
