**ORDER
(INCOME TAX)**

Subject: - **JURISDICTION OF COMMISSIONERS OF INCOME TAX, LARGE TAXPAYERS' UNIT, ISLAMABAD.**

In exercise of the powers conferred by sub-section (1) of section 209 of the Income Tax Ordinance, 2001 (hereinafter referred to as the said Ordinance) and in supercession of all previous orders in respect of jurisdiction, the Federal Board of Revenue is pleased to direct that the Commissioners of Income Tax specified in column (2) of Table-A below, shall exercise the powers and perform the functions, under the said Ordinance, specified in column (3) of Table-A below, in respect of the persons, as specified in Table-B below.

2. It shall take effect from **15.01.2008**.

Commissioner of Income Tax (Enforcement and Collection Division).	a) Ensure compliance of filing statutory returns, statements, maintenance of prescribed accounts, documents and records, impose penalty and take other actions under the law against non-compliers, charge tax on defaulting withholding agents; monitor payment, collection and deduction of tax at source and issue exemption certificates; b) Communicate assessment orders/penalty orders and demand notices to Tax Facilitation Division; effect collection and recovery of tax under Part-IV, issue refunds under Part-VI and charge additional tax under Part-XII of Chapter-X, giving effect to an appeal order under Part-III of Chapter-X excluding orders arising out of audit and assessment, rectification of cases not related to audit; c) Impose penalty under Part-X of Chapter-X in respect of cases except selected for audit; d) Launch prosecution under Part-XI of Chapter-X; e) Disposal of external and internal audit observations/objections/paras; f) Conduct internal and external survey; g) Broadening of tax base and exercise jurisdiction for the

Commissioner of Income Tax (Taxpayers' Facilitation Division).	a) Receive returns, statements, statutory notices, documents, applications from taxpayers, mail from other income tax authorities, tax payment receipts (Challans) from Banks, and all outside communications; and b) Sort and disseminate information, documents, returns, statements and mail mentioned at (a) above, to concerned divisions or to income tax authorities, as the case may be. c) Communicate assessment orders/penalty orders and demand notices to taxpayers.
5.	Commissioner of Income Tax (Information Processing Division).	a) Maintenance of physical and electronic records; b) Receipt of communication from Tax Facilitation Division, Enforcement Division, Legal Division, Audit Division and other income tax authorities; c) Data entry of receipts and information contained in the communication from Tax Facilitation Division, Enforcement Division, Audit Division and other income tax

		authorities; d) Cross matching of information collected from taxpayers and other sources and issuance of discrepancy report to Audit Division. e) Dispatch of hard copies to different Divisions on demand; and f) Storage of information, documents, statements, returns and all other communications received from other Divisions, authorities, sources.
