**DRAFT ORDER  
(WEALTH TAX)**

Subject: - **JURISDICTION OF WEALTH TAX AUTHORITIES IN REGIONAL TAXPAYERS' OFFICE, LAHORE.**

In exercise of the powers conferred by sub-section (1) of section 9 read with clauses (a), (b) and (c) of sub-section (1) of section 10 of repealed Wealth Tax Act, 1963 (hereinafter referred to as the said Act) and section 3 of Finance Act, 2003 and in supercession of all previous orders in respect of jurisdiction, the Central Board of Revenue is pleased to direct that Income Tax authorities of Regional Taxpayers' Office, Lahore, as specified in column (2) of table below, shall also perform functions, as Wealth Tax authorities of Regional Taxpayers' Office, Lahore, as specified in column (3) of table below, under the said Act, in respect of persons or classes of persons or areas (excluding persons or classes of persons or areas assigned to any other RTO/LTU/Zone) falling within the Civil Districts of Lahore, Kasur and Sheikhupura of Civil Division Lahore of Province of Punjab.

2. It shall take effect from **17-10-2007**.
