Subject: **AMENDMENT IN STGO 15/2007 DATED 13-09-2007 – WITHDRAWAL OF FACILITY OF ZERO-RATING ON SUPPLY OF ELECTRICITY**

In exercise of powers conferred by clause (d) of section 4 of the Sales Tax Act, 1990, the Federal Board of Revenue is pleased to make the following further amendments in its Sales Tax General Order No. 15 of 2007 dated 13th September, 2007, namely:-

In the aforesaid General Order,

(a) in the preamble, in condition (c) the words, comma, full stop, figure and brackets “S.R.O. 509(I)/2007, dated the 9th June, 2007” shall be substituted by “S.R.O. 283(I)/2011, dated the 1st April, 2011”.

(b) In the table, the following serial numbers and all corresponding entries relating thereto shall be **omitted**:

Subject: **AMENDMENT IN STGO 15/2007 DATED 13-09-2007 – WITHDRAWAL OF FACILITY OF ZERO-RATING ON SUPPLY OF ELECTRICITY**

I am directed to refer to STGO of 2011 (vide which STGO 15 of 2007 dated 13-09-2007 was amended) whereunder the facility of zero-rated on electricity bills has been withdrawn from M/s Fayyaz Filament and M/s Progressive Fibres Ltd.. RTO is directed to conduct detailed scrutiny of these units to ascertain the use of electricity (which was charged sales tax @ zero percent) and whether the units were entitled to claim the benefit of zero-rating on electricity.
