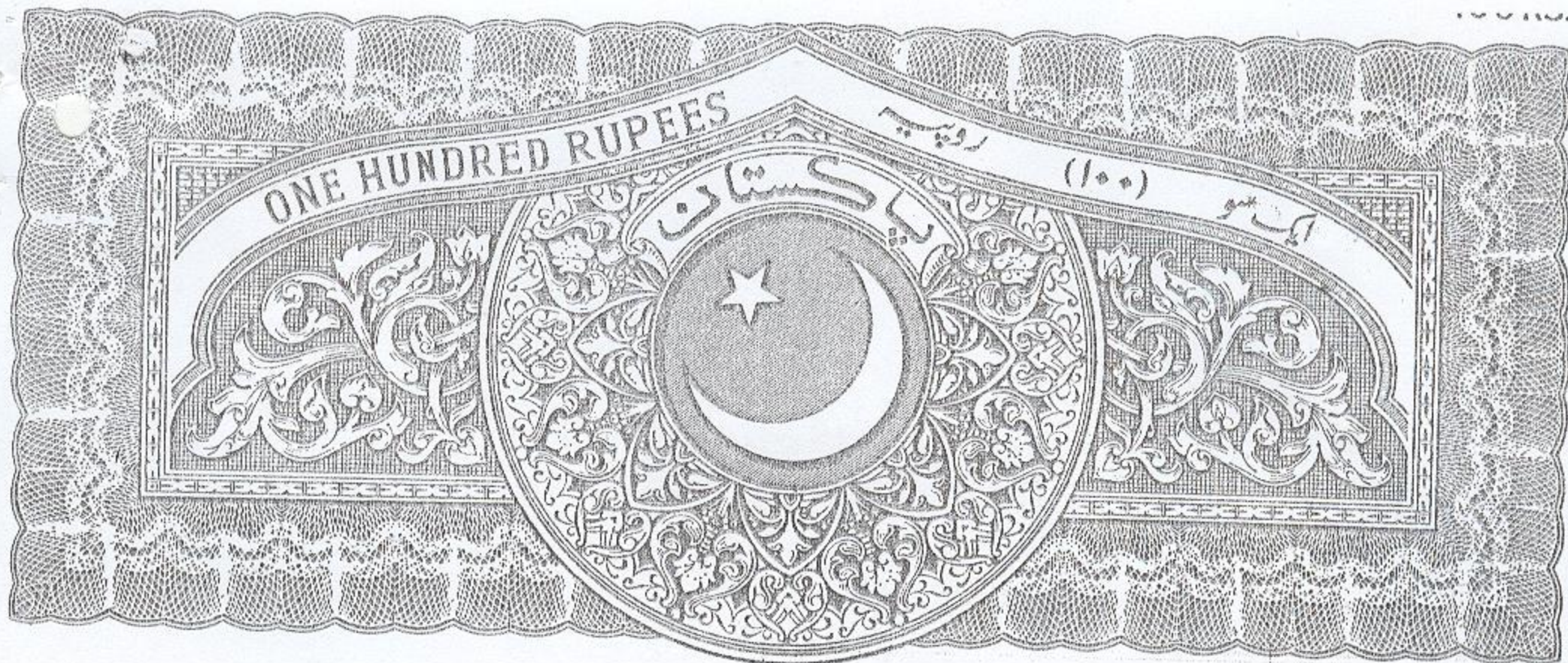


AGREEMENT

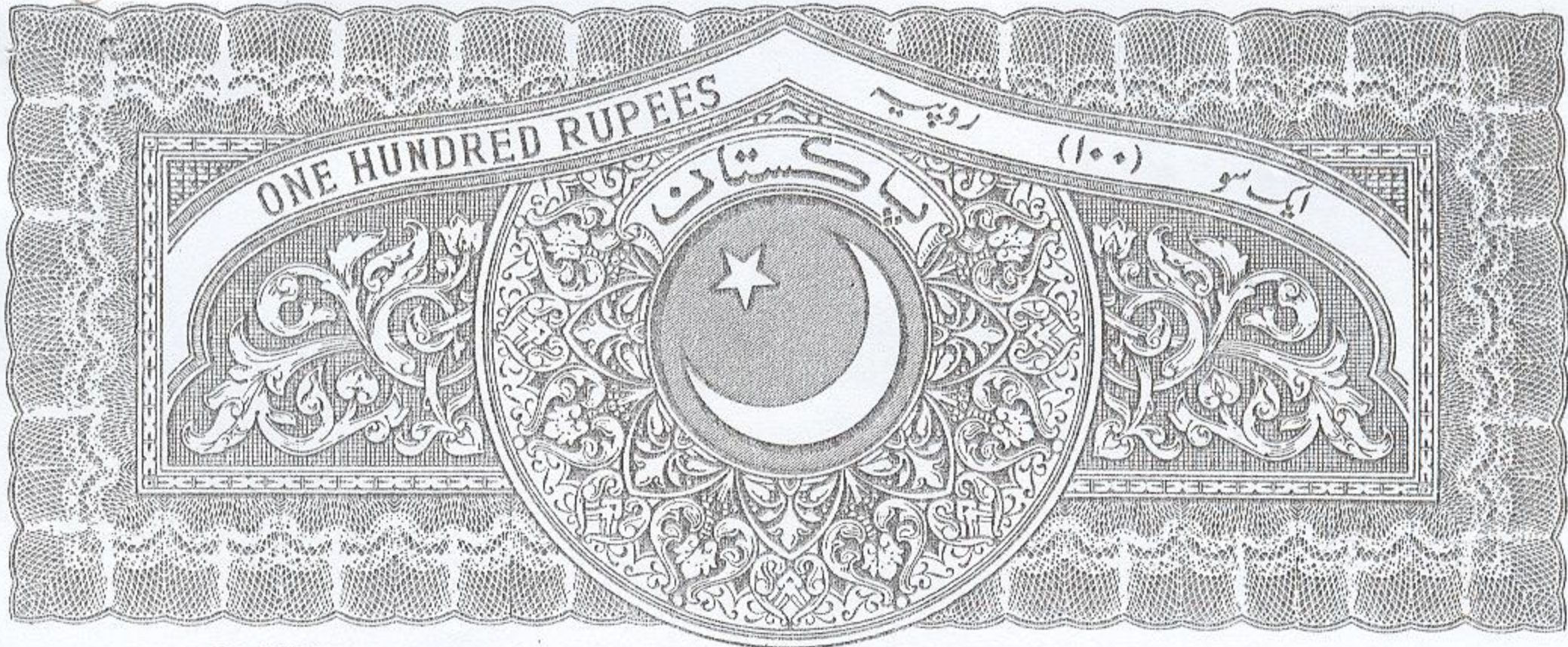
THIS AGREEMENT is made at Islamabad on this 28th day of February, 2009 between The President of Islamic Republic of Pakistan through **Chairman Federal Board of Revenue, Revenue(GOP)**, Constitution Avenue, Islamabad (herein after called "the Employer ") of the One Part and **M/s Shahan Construction Company**, having its registered office at **04 Kasi Plaza Zargoon Road, Quetta** through its Project In-Charge **Mr. Shah Rukh Khan S/O Masood Khan** having CNIC # 17301-5057187-1, Resident of H/No 146 A St 48, F 10/4 Islamabad authorized by Chief executive Haji Shakeel Ahmad having CNIC 51602-9332497-7 resident of New Badini st. new Muslimabad, Saryab road Quetta, duly empowered to sign this agreement for and on behalf of the company (hereinafter called "the contractor") of the other part, (herein after collectively called, "the parties").

Whereas the Employer is desirous that the contractor execute the works relating to Package-1 (Civil, Electrical, plumbing, HVAC and Mechanical works) for **Construction of Transit Accommodation for LTU Islamabad (Contract Identification No. 1(3)-SS-PTR/2007.** World bank Loan/Credited name "Tax "Administration reform Project" (hereinafter called "the Works") and the employer has accepted the Bid by the contractor for the execution and completion of such works and the remedying of any defects therein for a contract price not exceeding **Pak rupees 29,754,191 (twenty nine million seven hundred fifty four thousand and one hundred ninety one rupees only)**. (Hereinafter referred to as "the Contract Price".

NOW THIS AGREEMENT WITNESSED AS FOLLOWS:-

- 1 In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the bidding documents volume-1, conditions of the contract hereinafter referred to, and they shall be deemed to form and be read and construed as part of this Agreement.
- 2 In consideration of the payments to be made by the Employer to the contractor as hereinafter mentioned, the contractor hereby covenants with the employer to execute and complete the works and remedy any defects therein in conformity in all respects with the provisions of this agreement.
- 3 The employer hereby covenants to pay the contractor in consideration of the execution and completion of the works and the remedying of defects wherein the contract price or such other sum as may become payable under the provisions of this agreement at the times and in the manner prescribed by this agreement.
- 4 The contractor will not be entitled to any interest on account of any delayed payment(s).
- 5 The contractor hereby declares that it has not obtained or induced the procurement of this contract, right, interest, privilege or other obligation or benefit from government of Pakistan or any administrative subdivision or agency thereof or any other entity owned or controlled by it (GOP) through any corrupt business practice.

- 6 Without limiting the generality of the foregoing the contractor represent and warrants that it has fully declared the brokerage, commission, fees etc. Paid or payable to anyone and not given or agreed to give and shall not give or agree to give to anyone within or outside Pakistan either directly or indirectly through any natural or juridical person, including its affiliate, agent, associate, broker, consultant, director, promoter, shareholder, sponsor or subsidiary, any commission, gratification, bribe, finder's fee or kickback, whether described as consultation fee or otherwise, with the object of obtaining or including the procurement of a contract, right, interest, privilege or other obligation or benefit in whatsoever form GoP, except that which has been expressly declared pursuant hereto.
- 7 The Contractor certifies that it has made and will make fully disclosure of all agreements and arrangements with all persons in respect of or related to the transaction with GOP and has not taken any action or will not take any action to circumvent the above declaration, representation or warranty.
- 8 The contractor accepts full responsibility and strict liability for making any false declaration, representation and warranty. It agrees that any contract, right, interest, privilege or other obligation or benefit obtained or procured as aforesaid shall, without prejudice to any other right and remedies available to GoP under any law, contract or other instrument, be void able at the option of GoP.
- 9 Notwithstanding any rights and remedies exercised by GoP in this regard, the contractor agrees to indemnify GoP for any loss or damage incurred by it on account of its corrupt business practices and further pay compensation to GoP in an amount equivalent to ten times the sum of any commission, gratification, bribe, finder's fee or kickback given by the contractor as aforesaid for the purpose of obtaining or inducing the procurement of any contract, right, interest, privilege or other obligation or benefit in whatsoever from GoP.


