

#### CONTRACT

WHEREAS the Purchaser invited bids for the "Supply and Installation of Furniture for Regional Taxpayers Offices at various locations, LTU / MCC Islamabad" under Tax Administration Reform Project (TARP) and has accepted the bid submitted by the Supplier for the supply of furniture made in China under ICB No.1(58)SS(PTR)/04 in the sum of Rs.149,083,092/- (Rs. One Hundred Forty Nine Million, Eighty Three Thousand and Ninety Two) only (hereinafter called the Contract Price).

NOW THIS CONTRACT WITNESSWITH AS FOLLOWS:-



- 1. In this Contract words and expressions shall have the same meanings as are respectively assigned to them in the General Conditions of the Contract referred to.
- The following documents shall be deemed to form and be read and construed as an integral part of this agreement viz:
  - a) This Contract;
  - b) Special Conditions of Contract;
  - c) General Conditions of Contract;
  - d) Technical Requirements (including Schedule of Requirements and Technical Specifications);
  - e) The Supplier's bid and original price schedules and
  - f) The Purchaser's Notification of Award.
- 3. This Contract shall prevail over all other Contract Documents. In the event of any discrepancy or inconsistency within the Contract Documents, then the Documents referred to in Clause (2) above shall prevail in the order listed.
- 4. In consideration of the payments to be made by the Purchaser to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Purchaser to provide the goods and services and to remedy defects therein in conformity in all respects within the provisions of this Contract.
- 5. The Purchaser hereby covenants to pay the Supplier in consideration of the provisions of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by this Contract.
- 6. Supplier hereby declares that it has not obtained or induced the procurement of this Contract, or any right, interest, privilege or other obligation or benefit from the Government of Pakistan (GoP) or any administrative subdivision or agency thereof or any other entity owned or controlled by it (GoP) through any corrupt business practice.
- Without limiting the generality of the foregoing, the Supplier represents and warrants that it has fully declared the brokerage, commission, fee etc. paid or payable to anyone and not given or agreed to give and shall not give or agree to give to anyone within or outside Pakistan either directly or indirectly through any natural or juridical person, including its affiliate, agent, associate, broker, consultant, director, promoter, shareholder, sponsor, or subsidiary, any commission, gratification, bribe, finder's fee or kickback, whether described as consultation fee or otherwise, with the object of obtaining or including the procurement of this Contract, or any right, interest, privilege or other obligation or benefit in whatsoever form, except that which has been expressly declared pursuant hereto.
- 8. Supplier certifies that it has made full disclosure of all agreements and arrangements with all persons in respect of or related to the transaction with GoP and has not taken any action or will not take any action to circumvent the above declaration, representation or warranty.
- 9. Supplier accepts full responsibility and strict liability for making any false declaration, not making full disclosure, misrepresenting facts or taking any action likely to defeat the purpose of this declaration, representation and



warranty. It agrees that any contract, right, interest, privilege or other obligation or benefit obtained or procured as aforesaid shall, without prejudice to any other rights and remedies available to GoP under any law, contract or other instrument, be void able at the option of GoP.

10. Notwithstanding any rights and remedies exercised by GoP in this regard, the Supplier agrees to indemnify GoP for any loss or damage incurred by it on account of its corrupt business practices and further pay compensation to GoP in an amount equivalent to ten times the sum of any commission, gratification, bribe, finder's fee or kickback given by Supplier, as aforesaid for the purpose of obtaining or inducing the procurement of any contract, right, interest, privilege or other obligation or benefit in whatsoever form.

## 11. Payment for the goods supplied from abroad and related services shall be as under:

- (i) Advance Payment: Ten (10) percent of the CIP price shall be paid to the Local Agent within thirty (30) days of signing of the Contract, and upon submission of claim and a bank guarantee for equivalent amount valid until the goods are delivered at the final destinations and in the form provided in the bidding documents or another form acceptable to the Purchaser.
- (ii) On Shipment: Sixty (60) percent of the CIP price of the Goods that have been shipped shall be paid, through letter of credit opened in the favor of Local Agent, upon submission of documents specified in GCC Clause 12.
- On Acceptance: (After Installation): Thirty (30) percent of the CIP Price of goods that have been installed shall be paid to the Local Agent within thirty (30) days of the submission of claim supported by the acceptance certificate issued by the Engineer and the Purchaser declaring that the goods have been satisfactorily installed.
- (iv) Local Currency Portion 100% of the Local currency portion, relating to the inland transportation, related services, etc of the goods that the have been delivered shall be paid to the Local Agent in Pak. Rupees within thirty (30) days of presentation of claim supported by a certificate issued by the Purchaser declaring that the goods have been delivered at site and issuance of inspection certificate and approval by the Engineer.
- 12. The Supplier shall not be entitled to any interest on account of any delayed payment(s).
- 13. The Supplier shall ensure that acceptance by Purchaser at the final destination clearly states that the physical verification of the technical specifications of the goods delivered are in accordance with the technical requirements specified in this Contract.
- 14. This Contract shall be governed by the Laws of the Islamic Republic of Pakistan and the courts of Pakistan shall have exclusive jurisdiction.
- 15. This Contract is executed between the Parties provisionally in order to commence the Contract obligations till the formal Contract is vetted by Ministry of Law, Justice and Human Rights
