Subject:- DISBURSEMENT OF PAY AND ALLOWANCES FOR THE
MONTH OF OCTOBER, 2012 IN ADVANCE TO ALL FEDERAL
GOVERNMENT SERVANTS AND PENSIONERS

Madam,

I am directed to refer to Federal Treasury Rule 217 Note-4 which provides that if the Festival of Eid-ul-Fitr, Eid-ul-Azaha, Dussehra, Diwali, Easter Monday Parghat Day, Guru Balmik Swamiji, Guru Nanak's Birthday or Christmas falls within the last ten days of a month, pay, allowances and pension of that month may be disbursed in advance to all Federal Government servants and to all Pensioners of the Federal Government belonging to the community which is observing the festival not earlier than five days before the festival.

2. As Eid-ul-Azha is likely to be observed on 26th / 27th Oct-2012, subject to moon citing, hence it has been decided that the salary, allowances and pension for the month of October, 2012 may be disbursed on 22nd October, 2012 to all Government Servants/Pensioners (both Civil and Armed Forces).

3. It is requested to take necessary action accordingly.
