SALES TAX GENERAL ORDER NO. 03 OF 2012

Subject: **AMENDMENT IN STGO 11/2007 DATED 13-09-2007 WITHDRAWAL OF FACILITY OF ZERO-RATING ON SUPPLY OF ELECTRICITY.**

In exercise of powers conferred by clause (d) of section 4 of the Sales Tax Act, 1990, the Federal Board of Revenue is pleased to make the following further amendments in its Sales Tax General Order No. 11 of 2007 dated 13th September, 2007, namely:-

In the aforesaid General Order,

(e) In the preamble, in condition (c) the words, comma, full stop, figure and brackets "S.R.O. 509(I)/2007, dated the 9th June, 2007" shall be substituted by "S.R.O. 1125(I)/2011, dated the 31st December, 2011".

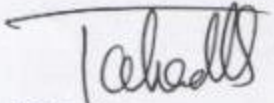
