- iv. M/s. Techaccess Limited.

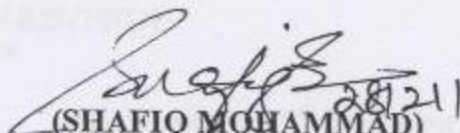
