Subject:- **AMENDMENT TO THE JURISDICTION OF COMMISSIONERS
INLAND REVENUE, REGIONAL TAX OFFICE, MULTAN.**

In exercise of the powers conferred by sub-section (1) of section 209 of the Income Tax Ordinance, 2001, sub-section (1) of section 30 and section 31 of the Sales Tax Act, 1990, sub-section (1) of section 29 of the Federal Excise Act, 2005, the Federal Board of Revenue is pleased to amend Board's Notification C.No.57(2) S.DOS/2011-28916-R dated 28-02-2011, in respect of Commissioners Inland Revenue, Regional Tax Office, Multan as under:

2. In entry No.1 of CIR (Zone-I), RTO, Multan in Para (b) of Column(4), the word "not" is inserted between the words "otherwise" and "assigned".

3. In entry No. 2 of CIR (Zone-II), RTO, Multan in Para (a) of Column (4), the following entries are deleted/ modified;

vii. & xv.	The words "Auto parts" and "Importers/Exporters" are deleted.
ix. xii. xiii & xvii	These Serial Numbers are deleted.

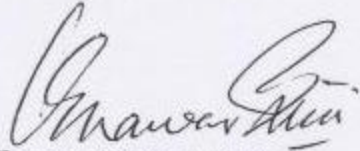
4. In para (a) of column (4) of entry No. 2 of CIR(Zone-II), RTO, Multan following amendments in respect of classes are made:

- * In sub para (i), after the word "and" the words "manufacturer, wholesalers, distributors and dealers of" are added.

- * In sub para (ii) before the words "Soap" the words "manufacturer, wholesalers, distributors and dealers of" are added. The word "and" is inserted "Soap" and "Soap Stock".

5. In entry No.2 of CIR(Zone-II), RTO, Multan in para (f) the words "existing in the territorial limits" are substituted with the words "falling in the jurisdiction".

6. This Notification shall take immediate effect.
