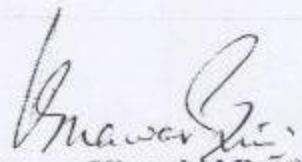

In exercise of the powers conferred under Sub-Section (1) of Section 30 and Section 31 of the Sales Tax Act, 1990, Sub-Section (1) of Section 29 of the Federal Excise Act, 2005 and in partial modification to Board's Orders vide C.No.57(2)S-DOS/2011-28913-R dated 28.02.2011 and C.No.2(1) SS (IR-Jurisdiction)/2011 dated 10.05.2011, in respect of jurisdiction of the Large Taxpayers Unit, Islamabad, the Federal Board of Revenue is pleased to assign jurisdiction of cases pertaining to the jurisdiction of LTU, Islamabad to the Commissioners Inland Revenue as per schedules hereunder:-
