Subject: **AMENDMENT TO JURISDICTION OF COMMISSIONERS
INLAND REVENUE, REGIONAL TAX OFFICE-III, KARACHI**

In exercise of the powers conferred by sub-section (1) of section 209 of the Income Tax Ordinance, 2001, sub-section (1) of section 30 and section 31 of the Sales Tax Act, 1990, sub-section (1) of section 29 of the Federal Excise Act, 2005, section 7 of the Finance Act, 1989 (V of 1989) and Wealth Tax Act, 1963, as amended by the Finance (Amendment) ordinance, 2009, and in supersession of all previous notifications in this respect the Federal Board of Revenue is pleased to amend the notification No. 57(2) S-DOS/2011-29524-R dated 01.03.2011 in respect of Commissioners Inland Revenue, Regional Tax Office-III, Karachi as under;

- A. Para (viii) in column 4 of Sr. No. 1 at page 2 for Zone-I shall be omitted and replaced as under;

"(viii) All Provincial / Federal Government employers whose names begin with alphabet A to M and are located in former Civil Division of Karachi; and"

- B. Para (viii) in column 4 of Sr. No. 2 at page 4 Zone-II shall be omitted and replaced as under;

"(viii) All Private Sector employers whose names begin with alphabet A to F and are located in former Civil Division of Karachi; and"

- C. Para (viii) in column 4 of Sr. No. 3 at page 6 Zone-II shall be omitted and replaced as under;

"(viii) All Provincial / Federal Government employers whose names begin with alphabet N to Z and are located in former Civil Division of Karachi; and"

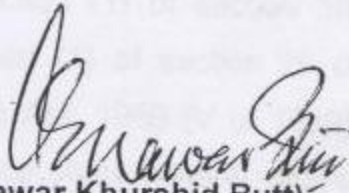
- D. Para (vi) in column 4 of Sr. No. 4 at page 7 Zone-IV shall be omitted and replaced as under;

"(vi) All Private Sector employers whose names begin with alphabet G to M and are located in former Civil Division of Karachi; and"

- E. Para (ix) in column 4 of Sr. No. 5 at page 09 Zone-IV shall be omitted and replaced as under;

"(ix) All Private Sector employers whose names begin with alphabet N to Z and are located in former Civil Division of Karachi; and"

2. It shall take immediate effect.

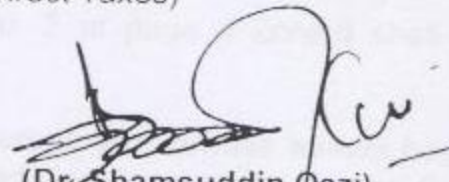
