INLAND REVENUE, LARGE TAXPAYERS UNIT, ISLAMABAD.**

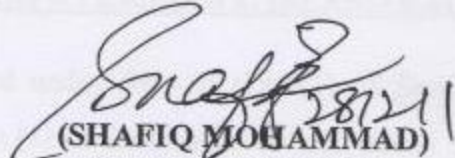

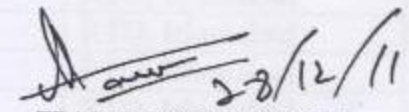
