SALES TAX GENERAL ORDER NO. 13 OF 2012

Subject: **AMENDMENT IN STGO 16/2007 DATED 13-09-2007 – ALLOWING FACILITY OF ZERO-RATING ON SUPPLY OF GAS BY SSGCL.**

In exercise of powers conferred by clause (d) of section 4 of the Sales Tax Act, 1990, the Federal Board of Revenue is pleased to make the following further amendments in its Sales Tax General Order No. 16 of 2007 dated 13th September, 2007, namely:-

In the aforesaid General Order,

- (a) In the table, serial number 967 in column (1) and entries relating thereto in columns (2), (3) and (4) shall be **omitted**;
- (b) in the table, after serial number 967 in column (1) and the entries relating thereto in columns (2), (3) and (4), the following new serial numbers and the entries relating thereto shall be **added**, namely:-

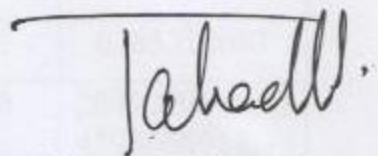
