Islamabad, the 30th May, 2012.**SUBJECT: RESTRICTIONS ON INFORMATION SYSTEMS USAGE DURING
FEDERAL BUDGET 2012-13.**

Due to Budget announcement on 1st June, 2012, restrictions on the access of servers/information systems running at FBR (HQ) will come in force from 30th May Mid-day to 1st June, 2012 as per following details:-

Sr.No.	System	Details
1	e-Dox	<ol style="list-style-type: none">Messages and Engagement features will be disabled and would not be accessible for the internal users of FBR House.Users located in the FBR House premises would only be limited in routing/marketing their correspondence in the wings located within FBR House premises; No one within FBR (HQ) will be allowed to mark/route and file/document to FBR wings/ Offices outside FBR (HQ) premises. However, external users such as RTOs/LTUs/ MCCs would be able to mark their correspondence to the internal users/wings of FBR.All training versions of the e-dox system would be un-accessible during the budget days.Help desk for e-Dox will be closed.
2	HRIS	Access to the system for correction of disposition lists, online application of leave and other facilities will be completely banned for field formations. Help desk for HRIS will be closed.
3	e-FBR Portal	FBR portal/Server will remain accessible for authorized users outside FBR (HQ) premises but no one within FBR (HQ) will be allowed to access e-FBR portal during Budget Exercise.
4	STARR & SALES TAX SYSTEM	STARR & Sales Tax System / Server will remain un-accessible for FBR (HQ) users, however, authorized users/outside FBR (HQ) premises will be allowed to access the system/Server.

5	PRAL & FBR Network & Internet	While the local networks of PRAL (HQ)/Evacue Trust/CDA Block 2 offices and FBR (HQ) will remain operational individually, transfer of any file/document from FBR (HQ) Network to PRAL(HQ)/Evacue Trust/CDA Block 2 offices Network and vice versa will be banned. Internet service in FBR will remain unavailable in FBR (HQ) from 30 th May to 1 st June, 2012.
