NOMINATIONS FOR 14TH MID CAREER MANAGEMENT COURSE

(MCMC).

The undersigned is directed to say that successful completion of Mid Career Management Course (MCMC) has been made mandatory for promotion from BS-18 to BS-19 with effect from 1st January, 2009 vide Establishment Division's O.M.No. 1/7/2006-CP-II dated 31.05.2008. All the Ministries/ Divisions/ Departments are, therefore, requested to nominate officers of BS-18 in promotion zone for the upcoming MCMC.

Nominations may be made according to seniority and fitness of officers for 2.10 promotion. If the senior officers on the panel are not nominated, the responsibility for deferment of their promotion shall lie with the respective organizations. Nominating agencies are, further requested that the nominees be relieved on time to enable them to accomplish their professional requirements. The criteria for making nominations are as follows:-

> The nominee should be in the promotion zone. 1)

An officer who is on long leave/deputation with IIN agencies or ii) international organizations may not be nominated.

The nominations should be made in order of seniority and an officer iii) otherwise senior to the nominee may not be ignored except on account of disciplinary proceedings.

Nominations should accompany a "Certificate that No Disciplinary iv) Proceedings are pending or going on under E&D rules or any other court of law" and the seniority list of respective officers in BS-18.

Those who have attained the age of 50 years are exempted from this v) course.

3. The Ministries/Divisions may send two separate panels for officers belonging to regularly constituted occupational groups and ex-cadre officers under their administrative control. As nomination of DMG, PSP and OMG officers of BPS-18 will be made by the Establishment Division itself, officers belonging to these groups are not required to be included in the panels prepared by the Ministries/ Divisions/ Departments/ Provincial Governments.
