Subject:- AUSTERITY MEASURES DURING FINANCIAL YEAR 2012-13

The undersigned is directed to state that the Cabinet has been pleased to approve continuation of austerity measures in current expenditure notified in 2011-12 during financial year 2012-13 w.e.f. 1-7-2012. These include:-

- (1) Ban on purchase of physical assets including all types of vehicles. Ban on purchase of vehicles will also be applicable to development expenditure.
- (2) Expenditure on Travelling Allowance, Repair of Transport and POL/CNG will be curtailed by 20% of allocated budget under these Heads.
- (3) Only one daily newspaper will be allowed to the entitled officers.
- (4) Officers will not be allowed to use Air-Conditioner before 11.00 a.m. and below 26 degrees.
- (5) Principal Accounting Officers will ensure rationalization of utility bills.
- (6) Serving of official lunches/dinners should be restricted to bare minimum.
- (7) Ministries/Divisions will not be authorized to re-appropriate funds from the above mentioned heads of expenditure.


