My dear Sir/Madam,

All the heads of field offices were reminded vide Board's letter dated 29-06-2012 and 19-07-2012 for furnishing of monthly expenditure reports to the Board on POL/CNG and Repair & Maintenance of operational vehicles by 5th of every month positively for onward submission to Finance Division, Cabinet Division and Public Accounts Committee (PAC). However, the reports are not being received by the above mentioned date which is causing late submission of these reports to the Finance Division and Cabinet Division.

2. The PAC has shown its displeasure to the Secretaries of the Ministries/Division who are not sending regular monthly reports to Finance Division and Cabinet Division and directed that Establishment Division may initiate disciplinary action against Seretaries of the ministries who fail to submit the monthly reports by the target date. In order to avoid any adverse direction/action by the PAC/Finance Division/Cabinet Division all the heads of field offices are reminded to personally monitor/ensure furnishing of monthly expenditure reports to the Board by 5th of every month positively on the prescribed proforma(Copy again enclosed). Delay in submission of reports by the target date will tantamount to disciplinary action against the concerned Heads of the field offices of FBR.
