SALES TAX GENERAL ORDER NO. 06 OF 2013

Subject: AMENDMENT IN STGO 09/2007 DATED 13-09-2007 – ALLOWING / WITHDRAWAL FACILITY OF ZERO-RATING ON SUPPLY OF ELECTRICITY.

In exercise of powers conferred by clause (d) of section 4 of the Sales Tax Act, 1990, the Federal Board of Revenue is pleased to make the following further amendments in its Sales Tax General Order No. 09 of 2007 dated 13th September, 2007, namely:-

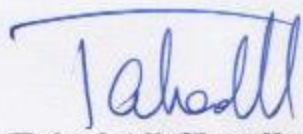
- (b) against S.N.o. 527 in column (1), in column (4), after the figure “24334151032000U” the figure “24131615103201R” shall be **added**;
