Subject: **AMENDMENT IN STGO 36/2010 DATED 24-09-2010 WITHDRAWAL FACILITY OF ZERO-RATING ON SUPPLY OF ELECTRICITY.**

In exercise of powers conferred by clause (d) of section 4 of the Sales Tax Act, 1990, the Federal Board of Revenue is pleased to make the following further amendments in its Sales Tax General Order No. 36 of 2010 dated 24th September, 2010, namely:-
